

Corrigendum to Tender Notice No. VP/IISF-K/0007/Tenders-Vehicle/IISF-2019/ Dated: 10.09.2019

Due to administrative reasons, the eligibility criteria as well as last date of tender submission has been revised as follows:

1. The last date for the tender submission is extended up to 10 October 2019 up to 11.00 AM.
2. Technical bids would be opened on 10 October 2019 at 11.30 AM
3. Financial bids would be opened on 10 October 2019 at 2.30 PM.

The eligibility criteria as defined in Para 3.1 to Para 3.10 of the above referred tender document is revised as under:

3.1 Agency should have minimum 5 years of experience as on date of tender.

3.2 Agency should have average annual audited turnover of at least Rs. 50 lakh from transportation activities only (which means income generated from vehicle supplied) in last 3 financial years upto 31.03.2019 (2016-17,2017-18 and 2018-19)

3.3 Agency must own at least 20 commercially registered vehicles (such as Maruti Dezire Indigo, Innova, Honda City etc. and/or heavy vehicle such as Tempo Traveler, 19 Seater coach, Volvo 49 seater etc.) of different makes in the name of owner or the company/agency. All the vehicles should not be older than 5 years.

3.4 Agency should have supplied vehicles (light and/or heavy vehicle) of different makes to at least one event wherein they have supplied atleast 50+ vehicles, organised by the government and / or quasi government agencies / financial / multilateral agencies / private organisation in the last 5 years.

3.5 The agency should be a registered member of any one association like IATO/ TAAI/ ADTOI/ TAFI/ Ministry of Tourism, Govt of India or would have been supplying vehicles to any government of India office. Proof to be submitted.

3.6 The agency should have PAN No and should have filed Income Tax return for the last 3 Assessment Years. (In case of Partnership / Pvt. Ltd. firm PAN No. of firm is required & in case of Proprietorship firm PAN No. of proprietor is to be enclosed).

3.7 The agency should have obtained registration certificate for GST in bidder's/firm name.

3.8 Agencies should have office/s in Kolkata. If not, then selected agency should have to set up their office in Kolkata to serve the requirement of IISF-2019. (Proof in this regard, to be submitted).

3.9 Agency should not be blacklisted from the Union Government /any of the state Government/ Govt. of India or State government PSEs including Societies Autonomous bodies formed by any of them. An undertaking to this effect should be provided by the agency on appropriate stamp paper.

3.10 Individuals who have done piecemeal/freelance/ job work are not eligible for this tender

Besides, Help desk at Airport, Hawrah Railway Station and Sealdah Railway station are to be established to facilitate participant. Help desk is to be manned by three personnel at a time. This cost has to be suitably embedded in the financial bid
